

## USCG – Foreign Passenger Vessel Examination – COVID-19

On May 5, the Coast Guard Office of Commercial Vessel Compliance issued Policy Letter 21-02 "Foreign Passenger Vessel Examination COVID-19 Guidance" to provide guidance to the Cruise Ship National Center of Expertise and Officers in Charge, Marine Inspection on Coast Guard examination requirements for all foreign cruise ships seeking to resume suspended operations

## CDC issues Phases 2B and 3 of the Conditional Sailing Order

On May 5, the Centers for Disease Control and Prevention (CDC) released guidance for cruise ships to undertake simulated voyages with volunteer passengers as part of its COVID-19 Conditional Sailing Certificate application. This release includes the COVID-19 Conditional Sailing Certificate application, which is the final step before restricted passenger voyages. ## EMSA issues first revision of COVID-19 Guidance for Cruise Ship Operators

On May 12, The European Maritime Safety Agency (EMSA) and the European Centre for Disease Prevention and Control (ECDC) have published a first revision of their joint COVID-19 guidance for cruise ship operations. IMO – Marine Safety Committee

In May, Marine Safety Committee (MSC) adopted a resolution on "Recommended action to prioritize COVID-19 vaccination of seafarers". The resolution recommends that Member States and relevant national authorities prioritize their seafarers, as far as practicable, in their national COVID-19 vaccination programs (taking into account the <u>WHO SAGE Roadmap</u>). ## USCG – Navigational Safety Advisory Committee

On May 21, the Coast Guard issued a notice that the National Navigation Safety Advisory Committee (Committee) will meet via teleconference to discuss matters relating to maritime collisions, rammings, and groundings; Inland Rules of the Road; International

Rules of the Road; navigation regulations and equipment; routing measures; marine information; and aids to navigation systems. The meeting will be open to the public. The full notice can be viewed at this link: <u>Fed. Reg.</u> <u>86-97</u>

## USCG – Mental Health of Mariners

# National Transportation Safety Board

NTSB – Early Communication, Fast Action, Aids Rescue of Fishing Vessel Crew

On May 25, the NTSB released a Marine Accident Brief that credited the fast crew reaction and early communication with the Coast Guard with preventing any fatalities or serious injuries when the commercial fishing vessel Rebecca Mary sank while underway last year. ## Docket – Scandies Rose

On May 24, the NTSB opened the public docket on its ongoing investigation of the sinking of the commercial fishing vessel Scandies Rose which resulted in the death of 5 crew members. ## Accident Brief – Iron Maiden

On May 4, the NTSB issued a Marine Accident Brief regarding a fire on the Iron Maiden when in a shipyard for repairs. The NTSB found that the fire was able to start and spread without notice because no one was continually monitoring the vessel while fire detectors were shut off during repairs. # Congress

## House - DoT grants for implicit bias training

On May 7, Rep. Brown introduced <u>H.R. 3017</u>, bill to direct the Secretary of Transportation to provide a grant for research and training in the operation or establishment of an implicit bias training program. The text of H.R. 3017 is not yet available.

## House – Water Infrastructure Finance & Innovation

On May 7, Rep. Costa (D-CA) introduced <u>H.R. 3023</u>, a bill to amend the Water Infrastructure Finance and Innovation Act of 2014 with respect to budgetary treatment of certain amounts of financial assistance. The text of H.R. 3023 is not yet available.

House – Priorities for critical infrastructure employees during COVID pandemic

On May 7, Rep. Crawford (R-AR) introduced <u>H.R. 3025</u>, a bill to direct the Secretary of Transportation to adopt certain priorities with respect to critical infrastructure employees during the coronavirus pandemic. The text of H.R. 3025 is not yet available.

## House – Intermodal Improvement Grants

On May 7, Rep. DeFazio (D-OR) introduced <u>H.R. 3033</u>, a bill to amend title 46, United States Code, with respect to the projects eligible for certain port and intermodal improvement grants, and for other purposes. The text of H.R. 3033 is not yet available.

## House – seafood slavery

On May 11, Rep. Huffman (D-CA) introduced <u>H.R. 3075</u>, a bill to address seafood slavery and combat illegal, unreported, or unregulated fishing. The text of H.R. 3075 is not yet available.

#### House – Longshore benefits for COVID-19

On May 11, Rep. Mrvan (D-IN) introduced <u>H.R. 3114</u>, a bill to provide benefits authorized under the Longshore and Harbor Workers' Compensation Act to maritime workers who contract COVID-19. The text of H.R. 3114 is not yet available.

#### House - Working Waterfront Task Force

On May 12, Rep. Pingree (D-ME) introduced <u>H.R. 3160</u>, a bill to amend the Coastal Zone Management Act of 1972 to establish a Working Waterfront Task Force and a working waterfronts grant program. The text of H.R. 3160 is not yet available.

#### House – Mapping of Urban Flooding

On May 12, Mr. Quigley (D-IL) introduced <u>H.R. 3161</u>, a bill to establish a pilot program to enhance the mapping of urban flooding and associated property damage and the availability of such mapped data to homeowners, businesses, and localities to help understand and mitigate the risk of such flooding. The text of H.R. 3161 is not yet available.

#### House – Data for Transportation Planning Organizations

On May 13, Sen. Baldwin (D-WI) introduced <u>S. 1629</u>, a bill to require the Secretary of Transportation to carry out a pilot program to develop and provide to States and transportation planning organizations accessibility data sets. The text of S. 1629 is not yet available.

#### Senate – Waiver Process of Coastwise Laws

On May 13, Sen. Lee (R-UT) introduced <u>S. 1640</u>. A bill to establish a process for waiver of coastwise endorsement requirements. The text of S. 1640 is not yet available.

#### Senate – Repeal of the Jones Act

On May 13, Sen. Lee (R-UT) introduced <u>S. 1646</u>, a bill to repeal the Jones Act restrictions on coastwise trade. The text of S. 1646 is not yet available. However, Senator Lee did release a Press Release on the introduction of these bills: <u>Lee Press Release: Jones Act</u>

## Senate – Exemption from U.S.-build for Coast Guard vessels

On May 13, Sen. Lee (R-UT) introduced <u>S. 1647</u>, a bill to authorize an exception to the restriction on construction of Coast Guard vessels in foreign shipyards for certain construction in shipyards in North Atlantic Treaty Organization countries. The text of S. 1647 is not yet available.

#### Senate - Construction of U.S. Naval Vessels in NATO countries

On May 13, Sen. Lee (R-UT) introduced <u>S. 1648</u>, a bill to amend title 10, United States Code, to authorize the construction of naval vessels in shipyards in North Atlantic Treaty Organization countries. The text of S. 1648 is not yet available.

## House - Repeal of the Jones Act

On May 13, Rep. McClintock (R-CA) introduced <u>H.R. 3205</u>. A bill to repeal the Jones Act restrictions on coastwise trade. The text of H.R. 3205 is not yet available.

## House – Advisory Committee on Transportation Planning

On May 17, Rep. Wilson (D-FL) introduced <u>H.R. 3289</u>, a bill to re-establish an advisory committee to provide independent advice and recommendations to the Secretary of Transportation regarding comprehensive,

interdisciplinary issues related to transportation from a variety of stakeholders in transportation planning, design, research, policy, and advocacy. The text of H.R. 3289 is not yet available.

## Senate – Promotion of Transportation Careers

On May 18, Sen. Peters (D-MI) introduced <u>S. 1681</u>, a bill to amend title 49, United States Code, to promote transportation career opportunities and improve diversity in the workforce. The text of s. 1681 is not yet available.

#### Senate – Lifting of Trade Embargo with Cuba

On May 19, Sen. Klobuchar (D-MN) <u>S. 1694</u>, a bill to lift the trade embargo on Cuba. The text of S. 1694 is not yet available.

## Senate - Tax Credit for sustainable aviation fuel (why not maritime fuel?)

On May 20, Sen. Schneider (D-IL) <u>H.R. 3440</u>. A bill to amend the Internal Revenue Code of 1986 to provide a tax credit for sustainable aviation fuel. The text of H.R. 3440 is not yet available.

#### House - National Center for the Advancement of Aviation (why not maritime?)

On May 25, Rep. Carson (D-IN) <u>H.R. 3482</u>, a bill to establish the National Center for the Advancement of Aviation. The text of H.R. 3482 is not yet available.

## House – Grants for Zero Emission Passenger Ferries

On May 25, Rep. Larsen (D-WA) introduced <u>H.R. 3516</u>, a bill to amend title 49, United States Code, to authorize the Secretary of Transportation to make zero-emission or reduced emission passenger ferry grants. The text of H.R. 35316 is not yet available.

### Senate – pay for Coast Guard members

On May 26, Sen. Wicker (R-MS) introduced <u>S. 1845</u>, a bill to provide for pay and allowances for members of the Coast Guard during a funding gap, to provide full funding to address the shoreside facility maintenance and recapitalization backlog of the Coast Guard. The text of S. 1845 is not yet available.

# White House – Approval of 1<sup>st</sup> Offshore Wind Project

## Interior – Pacific Offshore Wind Agreement

On May 25, the Department of the Interior announced an agreement to advance areas for offshore wind off the northern and central coasts of California. ## MarAd - Merchant Marine Academy Admissions

On April 22, MarAd issued a final rule that adopts, without change, an October 22, 2020, interim final rule (IFR) amending Maritime Administration (MARAD) regulations governing admission to the United States Merchant Marine Academy (USMMA). The amendments allow the MARAD Administrator to waive the requirement for USMMA applicants to have taken the College Board's Scholastic Aptitude Test (SAT) or the American College Testing Program (ACT)

examination in the event of a State or national emergency. The ability to waive SAT and ACT requirements for prospective students is necessary to address testing disruptions caused by the coronavirus disease 2019 (COVID-19) pandemic and to provide for future emergencies. ## MarAd – Applications for grants for America's Marine Highway Program

On May 24, MarAd issued a notice that announced the availability of funding for grants and establishes selection criteria and application requirements for the America's Marine Highway Program (AMHP).
