

# International Propeller Club Member of the Year Mr. Dimitris Fafalios, Propeller Club of Piraeus, Greece

Mr. Dimitris Fafalios is President of Fafalios Shipping SA, a traditional, family-run bulk carrier shipping company that traces its roots back to the 1860s. He is currently serving his second term as Chairman of The International Association of Dry Cargo Shipowners (Intercargo). He also chairs the Bulk Carrier Panel of the International Chamber of Shipping (ICS) and the Maritime Safety and Marine Environment Protection Committee of the Union of Greek Shipowners (UGS). He also holds senior positions on committees of ABS and DNV-GL Class

Societies and has represented the Hellenic Republic of Greece at the International Maritime Organization (IMO).

Throughout his career, Mr. Fafalios has worked closely with many of the major classifications' societies and international shipping organizations to develop and implement rules for crew and ship safety. Seafarers' safety and the environment have been at the forefront of his efforts throughout the years. As Chairman of Intercargo, he has consistently strived to promote these values. His achievements and initiatives at Intercargo have been impressive in advancing the goals of the Association, namely the commitment to safety, operational quality, and the protection of the marine environment. He also was a leader in the challenges presented by the COVID-19 pandemic, particularly in emphasizing the dramatic plight of the crews aboard vessels and the severe problems associated with crew changes. In this last respect, Intercargo participates actively in the development of global solutions through the IMO.

When the award was announced, Mr. Fafalios remarked, "I am very honored and humbled to be named the International Propeller Club Member of the Year. As a member, and having served on the Board of the Propeller Club Port of Piraeus, I have come to appreciate its vibrant membership, which combines the wonderful international reach of the Club with the Piraeus and Hellenic entrepreneurial spirit. The Club both unites and supports good causes. My warmest thanks and appreciation to the President, the Board of Governors, and the members. Wishing you all God's strength and good health."

Mr. Fafalios is a graduate of the Massachusetts Institute of Technology and a lifetime member of the Propeller Club of Piraeus. Mr. Fafalios is a highly respected member of the Greek and international shipping community, and in 2020 he was named in Lloyd's List's 100 most influential people in global shipping.



# International Propeller Club Maritime Person of the Year Mr. Eric Roger Dawicki

The Maritime Person of the Year award for 2021 was bestowed upon Mr. Eric Roger Dawicki of Fairhaven, Massachusetts. Mr. Dawicki has served as the President and CEO of the Northeast Maritime Institute (NMI) since 1995. He also serves as the President and CEO of the Commonwealth of Dominica International Maritime Registry. During

his tenure at Northeast Maritime Institute, Mr. Dawicki was responsible for overseeing its growth from an exam preparation facility to a full-service maritime education and training institution, providing quality education to mariners at all levels. As a prominent maritime leader following the attacks of 9/11, Mr. Dawicki served a full term as a member of the United States Maritime Security Advisory Committee under both the Bush and Obama Administrations. On an international level, since 1996, he has participated in numerous U.S. delegations to the IMO and served on multiple committee and subcommittee meetings. Mr. Dawicki has also been a member of the Board of Governors and an Executive Governor of the IMO's World Maritime University in Malmo, Sweden.



# International Propeller Club Port of the Year Mr. Costis J. Frangoulis President, Propeller Club of Piraeus, Greece

The International Propeller Club's Port of the Year award was presented to the Propeller Club of Piraeus, Greece. This award recognizes the most outstanding Port, or Chapter, among the International Propeller Club's 70 Ports worldwide. In August, the Port of Piraeus completed a 15-month interactive, online

program of psychological support and empowerment for seafarers. This was a program funded by the Club, and it provided counseling to crew members on ships under Greek ownership. The Propeller Club of Piraeus also signed the Neptune Declaration on Seafarer Wellbeing and Crew Change. This initiative aims to alleviate the seafarer crisis by facilitating crew changes and repatriation. Despite the significant challenges posed by Covid-19, the Club was recognized for an astounding 80% growth in membership within the last year. At the same time, the Port's annual philanthropic program grew by 48% offering 14 scholarships and receiving a record 23 donations. The Propeller Club of Piraeus is led by Mr. Costis J. Frangoulis, President of the Board of Governors.

#### Jim Patti – International President

Throughout his more than 50 years working for the maritime industry, Mr. Patti has played an active leadership role in all major legislative efforts affecting the operation of U.S.-flag vessels in the foreign and domestic trades and the employment of American mariners. He began working in the maritime industry in

Washington, DC, at the Transportation Institute. He joined the Maritime Institute for Research and Industrial Development (MIRAID) in 1980 and became President of MIRAID in 1985, a position he still holds today. Mr. Patti is also Chairman of USA Maritime, the leading coalition representing U.S.-flag shipping companies operating U.S.-flag vessels in America's foreign trades and the maritime unions which provide the licensed and unlicensed crews for these vessels and their related maritime associations. In addition, he is currently a Member of the Board of the United Seamen's Service. Mr. Patti, a long-time member of the International Propeller Club, earlier served as the President of the Propeller Club of Washington, DC, and was a recipient of the International Propeller Club's prestigious Maritime Person of the Year award. He most recently served as the International Propeller Club's First Vice President. Mr. Patti is a graduate of George Washington University and the Catholic University Columbus School of Law.



#### Maria Conatser – 1st Vice President and Treasurer

Ms. Conatser has 26 years in the maritime industry serving in various financial, planning, and analytical roles with Ingram Barge Company. She most recently served as Treasurer, International Propeller Club, and has been active in the Propeller Club Port of Nashville for over 15 years. During her tenure at the Propeller Club Port of Nashville, she has served as

President, Secretary, and Treasurer. Ms. Conatser also serves on the YWCA's Finance Committee in Nashville/Davidson County. She is a graduate of Western Kentucky University and has an MBA from Belmont University.



#### Philippe DE GAUW – 2<sup>nd</sup> Vice President

Philippe de Gauw started his career as an officer in the Merchant Marine and after many years at sea, he focused on logistics and supply chain challenges within the corporate world. Ten years later, he had a change in the course of his career when he started his own company, Logis-Consult LTD, offering multinational companies his expertise in supply chain management and IT. He is also a guest professor at the Antwerp Maritime Academy.

Besides his professional career, he first became a member of the Propeller Club in 1997. Currently, he is Vice President of the IPC-Port of Algeciras, 2nd Vice President and member of the Board of Directors, and leadership team of the International Propeller Club.



#### Costis J. Frangoulis – 3<sup>rd</sup> Vice President

Costis J. Frangoulis is a Greek entrepreneur born in Athens, Greece, and a father of two daughters, Elli and Athena. He holds a B. A. from the University of Richmond, U.K in Economics and Business Administration since 1988. He is the Founder, President, and CEO of Franman Group which he formed in May 1991. For almost 3 decades, Franman has provided a wide range of services to the shipping

industry, focused on shipbuilding equipment, spare parts, ship repairs and service, maritime security, cyber security, and consulting. In the year 1996, he founded Imperium Shipmanagement SA which managed and owned 5 handy-size bulk carriers. After a decade and while the Dry Cargo market was booming, he decided to exit the market by taking advantage of the very high asset values at the time. Mr. Frangoulis is also the President of the International Propeller Club, Port of Piraeus, an Ambassador of the Sailors' Society in Greece, a non-executive member of the board of Sfakianakis Group and a member of the Advisory Board of the Academic Maritime Sector of the BCA College.



#### **Maryanne Richards - Vice President, Student Ports**

Maryanne Richards is the Director of Career Services at Massachusetts Maritime Academy, in Buzzard's Bay, Massachusetts. In that capacity, she works with students in shore-side majors and employers from many industries. She also serves as the faculty advisor for Mass Maritime's Student Propeller Club. As Vice President, Student Ports she manages and promotes the Student Port Program worldwide. She attended

Boston College where she earned a Bachelor of Arts degree, and Northeastern University in Boston, Massachusetts where she earned a master's degree in education.



#### Candy Nigretto - Vice President, Women's Propeller Club

Candy is the Vice President of the Women's Propeller Club of the United States and also serves as the Regional Vice President for the Pacific Coast Region of the Propeller Club. Candy retired in 2019 after working for the Port of Tacoma for 22 years. Previously she worked for SeaLand Services for five years and Tacoma Boatbuilding Company for 18 years. She is currently the Executive Director of the Tacoma Propeller Club, where she has been a member since 1987 and was President in 1997. She was awarded the Pierce County Maritime

Person of the Year award by her local club in 2005 and was The Propeller Club of the United States 2005 Maritime Person of the Year. Candy has attended every International Propeller Club Convention since 1989 and has been part of the Organizing Committee for two international conventions hosted by the Port of Tacoma.



Pat Patrick - Secretary

Pat Patrick graduated from the University of South Alabama and from Tulane Law School in 1984, where he served as Articles Editor for the Tulane Law Review. Prior to the formation of Patrick Miller LLC, he was a partner in a large New Orleans law firm. Pat's practice focuses on insurance, tort, indemnity, workers' compensation, and maritime issues. He has handled environmental and toxic tort cases regarding both property damage and personal injury aspects. He handles cases at all levels of the state and federal court systems. He is a registered lobbyist

in Louisiana. He has handled matters before agencies such as the United States Customs Service, United States and Louisiana Departments of Labor, the United States Trademark Trial and Appeal Board, the Louisiana Insurance Commission, the Louisiana Commission on Public Ethics, all gaming regulatory agencies in Louisiana and Mississippi, and the Louisiana Department of Public Health. Pat is a member of numerous professional organizations including the Defense Research Institute, Louisiana Association of Defense Counsel, and Association of Average Adjusters of the United States. He is past president of the New Orleans Port of the Propeller Club of the United States and is a Board member of the International Propeller Club of the United States. Pat is a frequent lecturer and writer on legal education topics, primarily involving insurance, workers' compensation, maritime law, and trial practice.
